HPCA Board Of Directors 2023 Election

In January 2023, the Hawks Prairie Community Association (HPCA) will have four open Board positions for owners who are interested in serving on the HPCA Board. The positions are for two-year terms and the Board is encouraging members to consider becoming a candidate for one of those positions. The application process will begin in September and more information, including application forms, will be available shortly.

The Master Association oversees common property in both Jubilee and Edgewater including the HPCA trail and pickleball courts. The HPCA has been awarded a grant by the Nisqually Land Trust that is currently being considered by the board. The HPCA Board consists of seven members from both Jubilee and Edgewater. The Board meets on the fourth Wednesday of every month at 5:30 p.m..

Any Jubilee or Edgewater owner in good standing is eligible to become a candidate for the Board. If you are interested in governance and interested in making decisions that affect the properties owned by HPCA, please consider running for a position.

No motorized vehicles of any type are allowed on the trail, no skateboards on the trail.

Please pick up after your pets AND dispose of all waste bags in a trash receptacle (yes, even recyclable doggie waste bags).

The Silverhawk retention pond near our the trail is the private property of the Silverhawk Community. Please do not use it as a dog run area for your pets - you are trespassing.

These rules are meant to protect everyone's safety and enjoyment of our amenities. We have had recent reports of abuse of these safety rules. Please share this information with someone if you believe they are unaware.

Upcoming Construction on Basketball Court

The Parks and Trails Committee along with the Board of Directors are happy to announce that work will begin towards the end of September to expand the current half court basket ball court to make it a full court.

In our last survey this was brought up by many residents as a desire to have a full court. The board has been working with the City of Lacey to confirm any permitting we may need and the contractor to have an esthetically pleasing addition to our community as well as providing more opportunity for full court basketball play.

Golf Course

The Links and Woodlands golf courses are the private property of Hawks Prairie Golf Club. They are not owned by Jubilee or HPCA.

The only people that have the right to use the golf courses are golfers that have paid a fee to the golf course.

The golf course property is not public park space for the enjoyment of Jubilee or Edgewater residents to walk, ride bikes, play in the sprinklers or have picnics.

Unless you have paid a golfing fee to the golf course, you are trespassing, interfering with paying golfers and endangering your own safety.

Golf balls can land ANYWHERE and can cause very serious injury or even death.

Please do not take your children on the golf courses for family time.

We have wonderful parks and a private trail that are much safer and belong to you.
